has not fundamentally changed. American gun ownership rates are comparable to the 1940s, '50s, and '60s. Yet mass public shootings are a modern phenomenon. Something changed—and the anti-gun lobby exhibits a remarkable lack of tenacity in finding out what, for an interest group that is so vocal and bombastic in its advocacy for dismantling a fundamental Constitutional right.

Following the Minneapolis shooting, Kennedy announced that the National Institutes of Health is launching studies to determine if psychiatric drugs—particularly SSRIs (selective serotonin reuptake inhibitors)—may contribute to violent behavior. The drugs carry FDA black box warnings specifically cautioning about increased risks of suicidal and homicidal ideation, particularly in younger patients.

"We are doing those kinds of studies now," Kennedy stated. "At NIH we're launching studies on the potential contribution of some of the SSRI drugs and some of the other psychiatric drugs that might be contributing to violence."

The timing of the mainstream media pushback betrays the real fear: a federal investigation led by someone in Trump's Cabinet actually following evidence rather than ideology.

Kennedy's critics cite studies showing that antidepressant prescriptions have increased dramatically while violent crime has decreased overall. But this argument sidesteps Kennedy's specific claim: the rise in mass public shootings—a distinct behavioral phenomenon—may

ing and unsubstantiated claims when it comes to beating the drum for gun control. Yet rather than backing down, Kennedy's NIH is launching formal federal studies to examine the potential connection between SSRIs and psychiatric medications to violent behavior. Meanwhile, Kennedy's core observation remains unanswered by his critics:

"People have had guns in this country forever. When I was a kid, we had shooting clubs at our school. Kids would bring .22 rifles to school and park them in the parking lot. Nobody was shooting up schools."

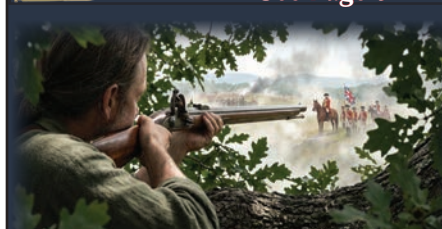

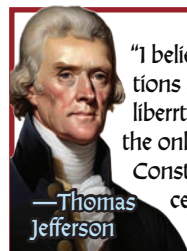

END THE DEBT

On March 2, Rep. Thomas Massie (R-Ky.) wrote on social media site, "X.com": "In 10 years, one quarter of all your taxes will go to interest paid to bankers and foreign countries. Interest on the national debt, the fastest growing part of the budget, is projected to more than double from \$970 billion in 2025 to \$2.1 trillion by 2036."

SPEND, SPEND, SPEND

Libertarian magazine Reason reported recently that federal appropriations under President Donald Trump ballooned in 2025 to \$7.01 trillion, up from \$6.93 trillion under Biden in 2024. The current estimate from the Congressional Budget Office (CBO) for fiscal year 2026 is \$7.4 trillion.

"COVER IT UP"

On March 7, Miami Herald reported that newly released Epstein files contain a five-page report of an FBI interview with an inmate, who awoke the morning of Aug. 10, 2019—the day convicted pedophile Jeffrey Epstein was found dead—to loud commotion in the Special Housing Unit where he and Epstein were jailed. The inmate told the FBI that he overheard a prison guard saying, "Dudes, you killed that dude." He then said he heard a female guard add, "If he is dead, we're going to cover it up, and he's going to have an alibi." The unnamed prisoner identified the female guard as officer Tova Noel, one of two correctional officers, who were later charged with falsifying reports so that it appeared they had made their rounds when they had not. The charges against Noel and the other officer, Michael Thomas, were later dropped, but both of them were fired.

SUSPICIOUS DEPOSITS

On March 7, The New York Post reported that newly released Department of Justice documents and FBI files have brought renewed attention to the actions of former prison guard Tova Noel, one of the prison guards

on duty at the Metropolitan Correctional Center when Jeffrey Epstein died in August 2019. The investigation highlighted several suspicious financial transactions involving Noel, including 12 cash deposits totaling \$12,000 that took place in the months preceding Epstein's death. The deposits were reportedly flagged as suspicious by Chase Bank, but the FBI never followed up on them.

THOUSANDS OF MUNITIONS

Since the start of the Israel-U.S. war on Iran on Feb. 28, the joint U.S.-Israeli campaign has dropped thousands of munitions on Iran. As of March 9, the Israel Defense Forces reported dropping approximately 7,500 munitions on targets across Iran. U.S. Central Command reported striking more than 5,500 targets in Iran as of March 11. The U.S. has utilized B-1 and B-2 bombers for strikes on hardened underground facilities and Tomahawk missiles from Navy ships.

NO MORE WARS

Pro-Israel news and commentary website "Daily Caller" reported on a Democracy Institute poll released March 10 that found that 80% of respondents in the United States believe President Donald Trump abandoned his 2024 campaign pledge to end foreign wars, including 85% of Republicans and 73% of Democrats.

WAR PRESIDENT?

Though he claims to be the peace president, President Donald Trump has attacked seven nations in his first year in office, three of which had never been targeted by U.S. military strikes in the past. In the last year, Trump has authorized more individual air strikes than Joe Biden did in all four years in office.

INSIDER TRADING

Congressional investigators say they are looking into six individuals, who made \$1 million gambling online on the exact start time of the war with Iran. The investigators contend that these people either

worked for the White House or the U.S. military and used inside information to profit.

MOON LANDING SCRAPPED

On March 3, NASA announced that it would be scrapping its Artemis III program that planned for a crewed lunar landing in the next few years. The mission will instead focus on in-orbit testing of landing systems and procedures, with the first crewed moon landing now aimed for 2028. In the meantime, China has been working on a lunar base that officials say will be manned by 2035. The Chinese also plan to begin landing their own astronauts on the moon before 2030.

YOUR PRIVACY SOLD

In 2025, Meta, the company that owns social media site "Facebook," sold 7 million Ray Ban "smart glasses" that have cameras built into them and allow users to access the Internet on them. A new lawsuit alleges that Meta workers in Kenya have been secretly watching footage from these glasses that is sometimes live, which shows people in the privacy of their own homes in all states of undress without the individuals' knowledge. Meta tried to argue that the glasses had blurred out people, but the protections failed regularly and the Kenyan workers were able to see everything including people's faces. Meta's defense is that this is all disclosed in the company's privacy policy, which the buyers consented to. That does not include other innocent parties in the homes, who never signed up for Meta in the first place.

HACKED EMAILS

According to independent journalist Ryan Grim, the warrant that was used to search the home of former top U.S. official John Bolton revealed that Iran had hacked Bolton's AOL email account on at least three times and that Bolton likely used his personal email to send classified information.

FAKE ROBOT CARS

A week after a Waymo robot taxi struck and injured a child near a Santa Monica, Calif., elementary school, Waymo officials have been forced to admit that humans operating out of the Philippines have to step in at times to remotely take over the supposedly automated robot taxi cabs, reports news and commentary website "Business Insider." During a recent congressional hearing, Waymo Chief Safety Officer Mauricio Peña was grilled over the company's use of Chinese-made vehicles and reliance on overseas workers. Sen. Ed Markey (D-Mass.) blasted the company, accusing them of destroying jobs in the United States and lying that their cars are completely automated. "We don't know if these people have U.S. driver's licenses," said Markey. "It's one thing when a taxi is replaced by an Uber or a Lyft. It's another thing when the jobs just go completely overseas."

RETAIL BLOODBATH

Two big-name U.S. retailers recently announced store closures just two weeks into 2026, and experts warn that the retail-shuttering roundup is only going to get more bleak as time goes on. Department store Macy's announced in early January that it was shuttering 14 "underproductive" stores, while Saks Global group filed for bankruptcy in late January. Last year, more than 8,000 chain retail stores across different companies were shut down, including Rite Aid, Joann fabric store, and Party City, among others.

STATING THE OBVIOUS

A nurse in the UK, who worked in the National Health Service for 12 years, was suspended recently and has been left in legal limbo after calling a transsexual male patient—who also happens to be a convicted pedophile—"mister." According to published reports, nurse Jennifer Melle is being punished for holding and expressing legally protected views in the UK. In April 2025, the UK high court ruled that "sex" under the Equality Act is defined by biology, not gender.

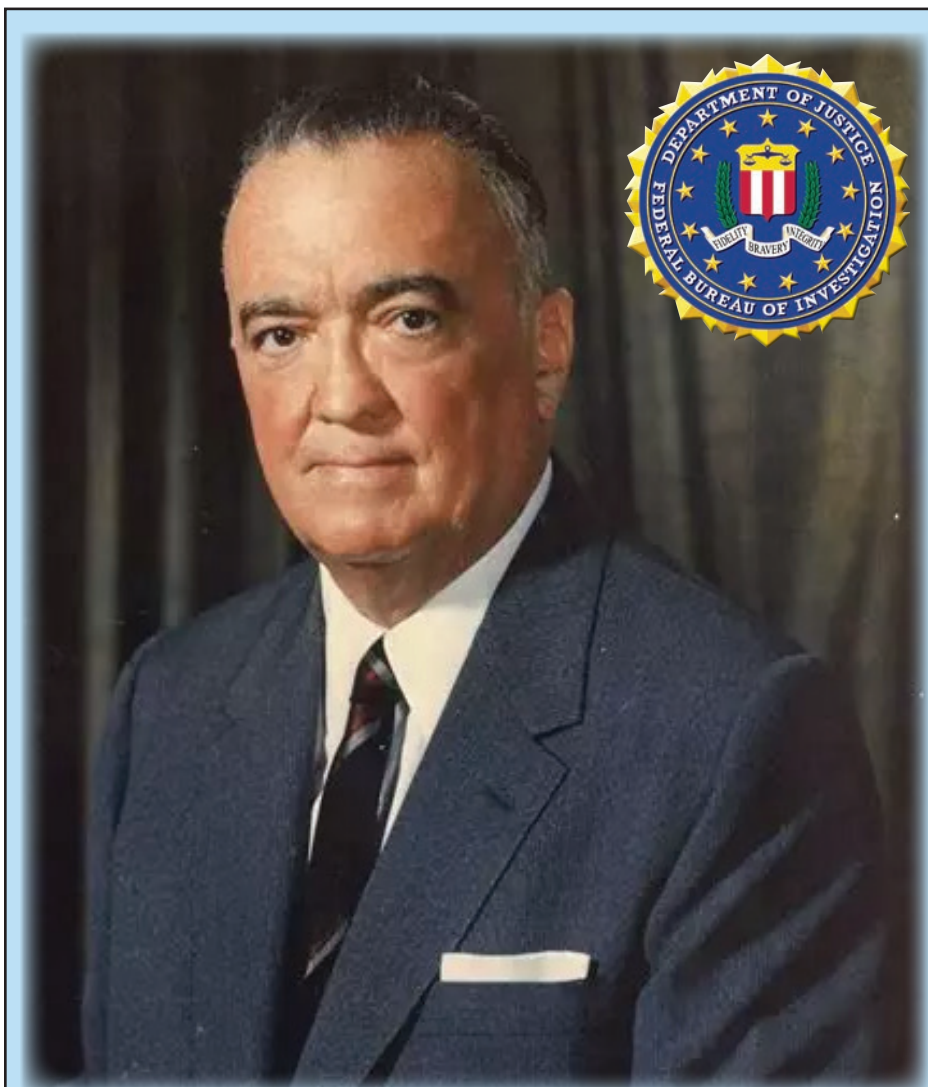

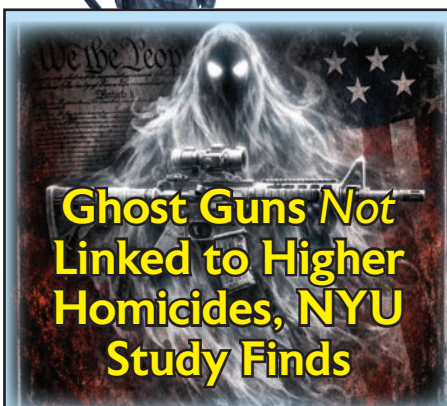

Ghost Guns Not Linked to Higher Homicides, NYU Study Finds

A new peer-reviewed study from New York University researchers has reignited the ghost gun debate—but the findings may surprise anti-gun activists pushing for restrictions.

Published in the *Journal of Epidemiology and Community Health*, the research analyzed firearm deaths across California's 58 counties from 2014 to 2023. The key finding: *ghost guns show no correlation with homicide rates*. Rather, a statistical association between ghost gun recoveries and firearm suicide rates. For every 20 ghost guns recovered per 100,000 residents, the firearm suicide rate increased by 6% the following year.

NYU researchers acknowledged the distinction matters. Most gun deaths in America are suicides—not homicides—and homicides typically involve firearms already present in homes during domestic disputes, not newly acquired untraceable weapons.

Professor Diana Silver from NYU's School of Global Public Health suggested ghost guns may appeal to individuals unable to pass background checks or seeking privacy—implying policy should address suicide prevention, not firearm access.

In spite of this, NY Governor Kathy Hochul and Manhattan DA Alvin Bragg are trying to leverage the study to push for 3D printer regulations and other restrictions. Bragg compared ghost guns to the "iron pipeline" of illegally trafficked arms in a ludicrous conflation with lawful manufacturing and criminal smuggling. ⚡



DOJ BACKS FPC MASSACHUSETTS BAN STRUCK DOWN

In a significant development for Second Amendment litigation, the United States Department of Justice has filed an amicus curiae brief with the First Circuit Court of Appeals, supporting Firearms Policy Coalition (FPC) in its ongoing challenge to Massachusetts's controversial handgun regulations. The case, *Granata v. Campbell*, targets the state's "Approved Firearms Roster" and Attorney General's handgun sales regulations, which plaintiffs argue unconstitutionally ban the commercial sale of handguns that are in common use nationwide.

Filed on January 28, 2026, the federal brief urges the appellate court to reverse a lower court's decision that upheld the state's restrictions. The DOJ argues that the Massachusetts scheme violates 2A by prohibiting the sale of firearms that are commonly used by law-abiding citizens for lawful purposes, particularly self-defense.

Cases like *Granata v. Campbell* highlight the critical role that legal advocacy plays in defending and restoring fundamental freedoms. The DOJ's decision to weigh in affirms that even within the federal government, there is recognition that state-level restrictions cannot supersede constitutional protections.

A favorable ruling could overturn the state's long-standing handgun restrictions and restore access to many constitutionally protected firearms for Massachusetts residents. ⚡

The New Mexico House's failure to advance SB 17 as the 2026 session closed is a narrow victory for firearms freedom, blocking what critics say would have been expansive regulation of law-abiding gun owners and small dealers.

Presented as a fix for trafficking and violent crime and backed by Everytown and similar groups, SB 17 contained broad language and dealer mandates that risked ensnaring hunters, collectors and families who rely on guns for self-defense. Opponents warned the bill would create longer waits, heavier paperwork, and new compliance costs—while doing little to stop criminals who obtain weapons through illicit channels.

Grassroots Second Amendment activists mobilized against provisions they say would expand state control over private transactions and inventory, and could be used as a veiled step toward registration-style tracking that chokes lawful commerce.

With the session adjourned, defenders of the Second Amendment plan to press for rights-respecting alternatives and hold lawmakers accountable at the ballot box. The outcome underscores the political clout of a mobilized gun-rights electorate and signals continued resistance to measures seen as eroding constitutional protections. ⚡



Trump Comments About Lawful Carry Draw Fire

President Trump's January comments condemning Alex Pretti's lawful carry during his fatal encounter with ICE officers last year have been the subject of ongoing backlash from the 2A community.

"You can't have guns. You can't walk in with guns," Trump told reporters Tuesday, followed by complaints that Pretti carried a fully loaded firearm with two extra magazines—conduct he described as "pretty unusual" and "a lot of bad stuff."

That Pretti's own belligerent and aggressive conduct got him killed goes without saying, but Trump's assertions fly in the face of key tenets of gun rights in America. 2A advocacy groups like The Second Amendment Foundation, NRA, Gun Owners of America, and allied groups have emphasized that carrying extra magazines is standard practice among permit holders and that lawful carry near officers should not justify lethal force.

US Attorney Bill Essayli and others initially walked back similar rhetoric after backlash. But Trump's latest remarks appear to negate those corrections, leaving some gun rights advocates questioning whether the administration's Second Amendment commitments extend beyond rhetoric.

The Trump administration has already demonstrated a devotion to 2A issue that should not be forgotten, but such careless assertions are concerning nonetheless. ⚡

To the free citizens and defenders of the Republic:

We stand at a crossroads of history and divine providence. The state of our armed union is strong, but the theater of conflict has shifted beneath our feet. As we survey the battlefield in these early months of 2026, the lines of demarcation have never been clearer. The administrative state continues to test the boundaries of its assumed authority, grasping at the remnants of defunct laws, but the stewardship of liberty remains exactly where God and the Founders intended it to reside: with the independent American, standing guard over his own family and property.

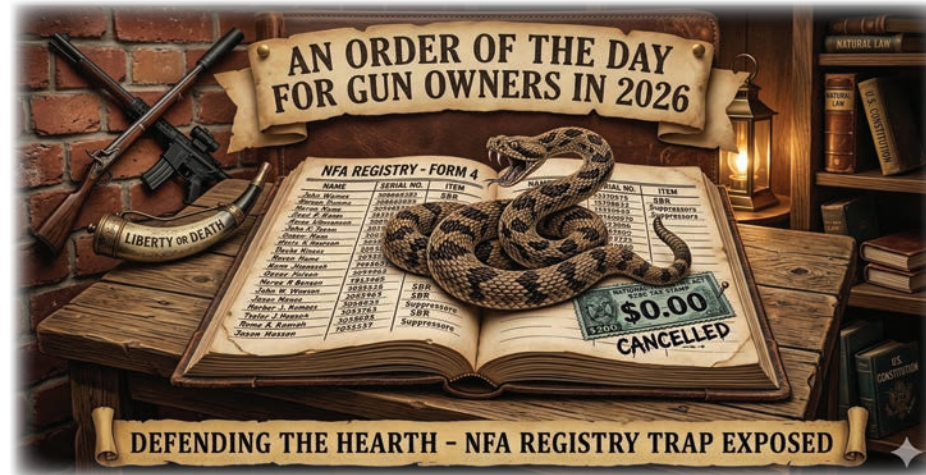
Consider this your Order of the Day. This is not merely a report on pending legislation; this is a tactical assessment of our standing as freemen. If you are paying attention, you know the fight is no longer simply about the hardware we keep in our armories. The true battle is over the fundamental legal mechanics the government uses to define who "The People" are, and by what assumed authority they dare to regulate a preexisting, Creator-endowed right.

Here is your real-time briefing on the immediate threats, the legal trapdoors, and the vital legislative front lines for patriots and gun owners.

I. THE "NFA SPRING" AND THE REGISTRY TRAP

On January 1, 2026, the federal tax stamp for Suppressors, Short-Barreled Rifles (SBRs), Short-Barreled Shotguns (SBSs), and Any Other Weapons (AOWs) was officially reduced from \$200 to \$0.

For the first time since the *National Firearms Act* was signed into law in 1934, the financial barrier to owning hearing protection and versatile defen-



sive tools has been eliminated. The industry is currently experiencing an unprecedented surge in e-Forms as Americans rightfully rush to exercise their liberties without paying an extortion fee to the Crown.

The Architects of the Siege

Let us be perfectly clear: this was no sudden act of bureaucratic benevolence. It was the result of a grueling legislative siege. The men who swung the battering rams to zero out this tax—stalwarts like Representatives Thomas Massie of Kentucky and Andrew Clyde of Georgia, backed by the uncompromising grassroots artillery of Gun Owners of America (GOA) and the Firearms Policy Coalition (FPC)—drew a line in the dirt.

As we highlight in this issue's Spotlight on Congress, these defenders of the Second Amendment refused to yield a single inch to the disarmament syndicate, holding the bloated enforcement budget of the ATF hostage until the extortion fee was stripped away. Faced with relentless pressure from the vanguard of the free citizenry, the administrative state blinked.

But it would not be prudent for gun owners to let their guard down just yet. While the tax is dead, the paperwork lives on.

Why did the federal bureaucracy ultimately concede the \$200? Because they are playing a longer, darker game. In the 1930s, the state knew an outright ban

on firearms would be blatantly unconstitutional. Instead, they relied on Congress's taxing power, successfully arguing before the Supreme Court in *Sonzinsky v. United States* (1937) that the NFA was strictly a revenue-generating measure.

Today, the emperor is entirely exposed. With the tax reduced to zero, the constitutional bedrock of the National Firearms Act has evaporated. The bureaucracy surrendered the revenue because they feared a post-Bruen Supreme Court might strike down the entire NFA if pushed. They traded the tax to save their most prized possession: the registry. They are no longer generating revenue; they are simply demanding a ledger of freemen.

Legal strikes are already in motion arguing that without a tax, the federal government has zero constitutional authority to maintain a database of these items whatsoever.

Until those lawsuits are won, however, we are navigating a treacherous frontier. Voluntarily submitting your fingerprints, your photograph, and your serial numbers to the ATF's Form 4 registry right now means putting your name on a federal ledger that has lost its legal justification.

History is brutally clear on this point: registration is the necessary prerequisite to confiscation. The state wants you to take the bait of a \$0 stamp so they can map the armories of the American citizenry. Concerned citizens should

proceed with the full, unyielding awareness of a free citizen guarding his inheritance.

II. SCOTUS WATCH: DEFINING "THE PEOPLE"

Just days ago, on March 2, the Supreme Court heard oral arguments in *United States v. Hemani*, a case that strikes at the very heart of the government's ability to arbitrarily disarm citizens based on "status."

At issue is 18 U.S.C. § 922(g)(3), which prohibits any "unlawful user" of a controlled substance from possessing a firearm. The defendant had his Second Amendment rights stripped and faced federal felony charges for possessing a firearm while admitting to using marijuana in the privacy of his own home. The Department of Justice essentially argued before the Court that the government possesses the historical authority to categorically disarm anyone who fits their broad, malleable definition of a "habitual user."

FROM THE BENCH: THE PUSH-BACK AGAINST TYRANNY

"If we look to the Founding era, men like John Adams and James Madison consumed cider and spirits daily. Are we to believe the Framers intended for a man to be entirely stripped of his natural right to self-defense merely for what he ingests in his own parlor, absent any violence?" > — Paraphrasing the inquiry of Justice Neil Gorsuch

"The historical tradition of this Nation allows for the disarming of dangerous persons. It does not allow the administrative state to create broad categories of non-violent 'status' simply to thin the ranks of the armed citizenry. Where is the finding of danger?"

Paraphrasing the scrutiny of Justice Clarence Thomas:

If the state can strip a man of his God-given rights based

purely on a non-violent lifestyle choice—without a specific, individualized finding by a jury that the person is actually a violent danger to his neighbors—then the Second Amendment is no longer a right; it is a conditional privilege managed by bureaucrats. A ruling against the state here would be a seismic victory for individual liberty, knee-capping the ATF's ability to use vague behavioral categories to usurp the rights of the people.

III. THE STATE-LEVEL SORT: SHIFTING FRONT LINES

While the federal courts debate the philosophy of the law, the states are taking immediate action. We are witnessing a "Great Sort" as states either cement the rights of their citizens or, like King George's regulars marching on Concord, attempt to seize the supply lines of the firearms industry entirely.

The Push for Constitutional Freedom

Just this week, Michigan House Republicans introduced a vital legislative package (HB 5653-5657) aimed at eliminating the requirement for a concealed pistol license, pushing to make Michigan the 30th Constitutional Carry state in the Union. Refusing to ask the government for a permission slip to defend your life, your property, and your kin should be the baseline in a free society. These legislators are fighting to restore that natural, Jacksonian order.

The Omnibus Threat and the Assault on the Supply Chain Conversely, the fight in New England has turned vicious. Vermont's H.606—the massive "Omnibus Gun Bill"—is scheduled for a hearing before the House Judiciary Committee on March 11.

This bill is pure legislative poison, designed to bypass the Second Amendment by attacking the very infrastructure of our defense. Beyond attempting to ban legally acquired items, Section 5 of H.606 is a direct, calculated assault on the supply chain. It seeks to completely



circumvent the federal Protection of Lawful Commerce in Arms Act (PLCAA) by allowing "Public Nuisance" lawsuits against the firearms industry. This is a backdoor attempt by anti-gun activists to sue local, Main Street FFLs and manufacturers into bankruptcy simply for selling lawful tools to law-abiding citizens.

THE BOTTOM LINE

The preservation of our liberties requires a populace that possesses the grit of Davy Crockett and the uncompromising principle of Samuel Adams. We must be a people who refuse to be bought, bullied, or regulated out of our birthright.

The bureaucratic state relies on a complacent citizenry willing to trade permanent rights for temporary conveniences or the illusion of safety.

Understanding the legal mechanics of these fights—from the collapse of the NFA's taxing power to the defense of the supply chain—is essential to our continued freedom. Refusing to compromise on these issues isn't merely a political stance; it is a mark of faithfulness to the principles this nation was built upon, and a necessary stewardship for the generations that will inherit this land after us.

We have secured a strategic foothold, and not just refused the line, but retaken ground in the battle for the second amendment. But the broader campaign for liberty has far from ended. The administrative state does not yield power easily; it merely regroups to lay more subtle snares.

We must meet this bureaucratic retreat with an unyielding vigilance, recognizing that a \$0 NFA tax is merely the cheese in a registry trap designed to map the armories of every free household. Complacency is the handmaid of tyranny.

We call upon every patriot to stay informed, mastering the legal and historical arguments that anchor our rights. We must remain watchful, scrutinizing the actions of every statehouse and court. We must provide material aid and unwavering support to the legal titans and legislative champions who are risking everything on the front lines.

Liberty is not a passive heritage to be stored away; it is a sacred fire that requires the ceaseless fuel of our collective devotion and active defense. Let the world know that the gun owners of America refuse to leave the field until total victory is secured and the last mechanism of bureaucratic control is dissolved. ⚔️

Rep. Thomas Massie (KY-4)

→ Co-chair of the Second Amendment Caucus.

→ Sponsor of the SAFER Voter Act, lifting handgun restrictions for 18–20-year-olds

→ Author of the National Constitutional Carry Act, a 2025/2026 push to ensure carry rights are recognized across all state lines. *"I work regularly with Gun Owners of America to protect Americans' constitutional right to keep and bear arms."*

Rep. Andrew Clyde (GA-9)

→ Successfully forced the \$0 Tax Stamp compromise into the 2025 "One Big Beautiful Bill" (effective Jan 1, 2026), zeroing out the \$200 NFA tax for suppressors and SBRs.

→ A leader in using the Congressional Review Act (CRA) to attempt to nullify ATF rules, such as those regarding universal background checks and pistol braces.

– Use platforms like Giffords Courtwatch to track active litigation and support amicus briefs.

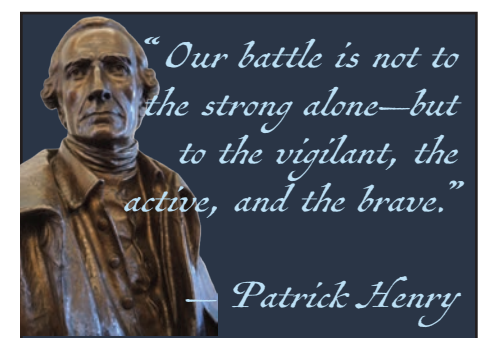
Step 3: Fire Them at the Ballot Box

Forgotten Heroes and Legends of Gun History: The Sharpshooter Who Turned the Tide at Saratoga

In the autumn of 1777, the cause of American independence was a candle in a gale. General John Burgoyne swept south with a plan to cut the colonies in two — a success that would have spelled disaster for the Continental army and the militias facing the British Empire. Things were looking bleak for the Revolution, but at the Battle of Saratoga a single man who embodied the martial soul of a nation still finding its identity would change the course of history. That moment was only one of many in a life built on riflecraft, faith, and frontier resolve.

Born to the Backcountry

Born in 1751 to Irish immigrants carving a life out of Pennsylvania's hill country, Timothy Murphy learned colonial riflecraft the way other boys learned a plow — by doing it until it became second nature. The Pennsylvania Long Rifle demanded patience, precision, and an almost liturgical attention to detail.

As everyone did at that time, he had learned to shoot a musket from a young age, but Murphy would soon gain a reputation as an exceptionally talented marksman.

Raised in a Presbyterian home in a community steeped in the Reformed tradition, neighbors and later county histories recall a frontier fighter whose faith gave him the moral clarity to act when others hesitated.

A Chosen Man

Murphy didn't wait for war. He enlisted with the Northumberland County Riflemen and survived the brutal year of 1776 — Long Island, the winter, Trenton and Princeton. His marksmanship and nerve earned him a place in Daniel Morgan's elite Corps of Riflemen, where he quickly became a leader.

Daniel Morgan was no ordinary commander. After surviving 499 lashes from a British whip — one short of the customary 500 — he joked the British still owed him the last stroke. Morgan didn't recruit; he culled. His standard was unflinching and exacting: a seven-inch target at 250 yards. To be chosen by Morgan was to be counted among the best.

The Shot Heard 'Round Saratoga

At Bemis Heights, the British onslaught was led by one of England's finest commanders in the colonies, General Simon

Fraser. His presence on the battlefield caused such a stir that he was quickly noticed by Benedict Arnold, whose own bravery that day is the stuff of legends. Seeing how effectively Fraser was rallying the British troops, Arnold said to Col. Dan Morgan, *"That officer on the gray horse is a host in himself and must be disposed of."* Morgan selected a small squad of his best riflemen, along with Murphy and pointed to Fraser saying *"I admire and respect him, but it is necessary for our good that he should die."* Murphy climbed a nearby oak tree and took aim at Fraser. After a couple of sighting shots, he delivered a fatal hit that dropped Fraser to the ground. The British formation, seeing their charismatic commanding officer fall,

lost their resolve and withdrew, winning the day. In light of Saratoga's significance and the role Fraser's sudden death played in the Continental Army's victory, this single shot arguably changed the course of the war and thereby American history as well.

The "Magic" Gun

As time passed, Murphy would go on to serve on the frontier, protecting settlers from Amerindian and Tory attacks. While serving in New York, Murphy acquired a highly irregular weapon for the time: a swivel

barreled flintlock called the Golcher rifle — an engineering marvel that allowed him to fire, rotate the barrel, and fire again with unheard-of speed. Consequently, Murphy gained a fearful reputation among Amerindian warriors as the man with a "spirit rifle" whose gun never had to be reloaded. Some accounts indicate it having a similar psychological impact on some British soldiers as well — who were purportedly so baffled and bumfuzzled by its novel two shot capacity that they dubbed it a "devil" or "magic" gun.

Sedition Rather Than Slavery

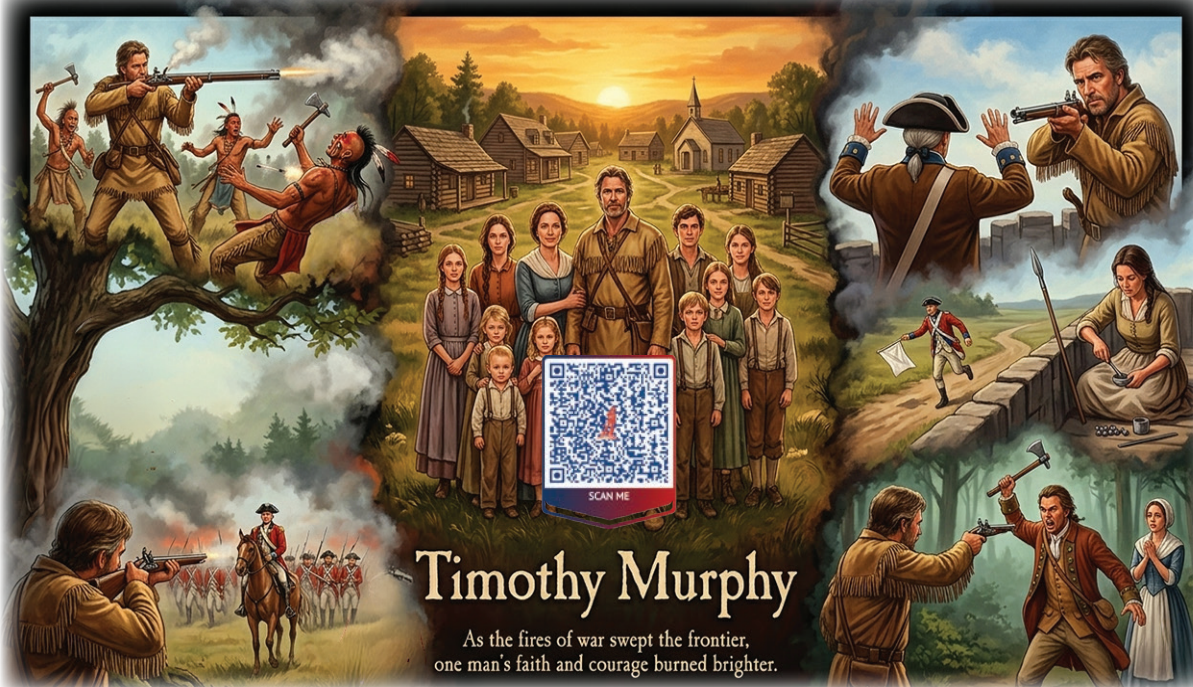
In 1780, Murphy was stationed at the Middle Fort. The fort's garrison was only 50 or so men, and facing an enemy force of 800, the commander was about to accept terms of surrender. But duty did not end here for Murphy. He fired on the British flag-bearer, and when threatened with execution for sedition, then leveled his rifle at his own commanding officer, informing him that he would sooner execute a coward than watch the fort fall. His wife, Peggy, sat near him calmly molding musket balls all the while, later saying she would pick up a spear and fight at her husband's side when the ammo ran out. The garrison stood its ground, and unwilling to risk a costly frontal assault, the British withdrew.

An Enduring Legacy

In time Murphy would settle down for the life of a farmer and patriarch, living to the age of 67 and siring 12 children. His grandson would eventually serve as the Governor of New York. His enduring legacy is living proof that the American story is one of guns and grit as much as as it is one of pens and principles. Murphy's life and legacy is the embodiment of a remarkable combination of both.

A Watchman of the Frontier

Murphy was a man of the Book, and he saw no contradiction between his faith and the necessity of violence. He under-



Forgotten Firearms: The Golcher Swivel Barreled Flintlock

Forever destined to be an undisputed icon of American resistance to tyranny in the annals of the American Revolution, is the Pennsylvania long rifle. As the standard issue weapon of Dan Morgan's riflemen, it is a legendary firearm to gun lovers and history buffs alike. But there existed a far more rare and more sophisticated weapon that struck a unique and special brand of terror into the hearsts of the British and their allies.

This was the Double-Barrel Over-and-Under Swivel Rifle, and in the hands of the legendary marksman Timothy Murphy, and other "special operators" of the period, it became a piece of colonial engineering that bridged the gap between frontier survival and high-stakes military intervention.

The Golcher Rifle and Its Origins

Designed and crafted by the master gunsmith John Golcher (or Goulcher) of Easton, Pennsylvania, this wasn't your standard issue Continental musket. At a time when a single shot followed by a 30-second or longer reload was the norm, the Golcher Swivel Rifle offered a terrifying tactical advantage: the unheard of ability to deliver a second deadly shot within seconds of the first one.

The gun featured two rifled barrels stacked vertically. To operate it, the shooter would fire the top barrel, depress a spring-loaded lever on the trigger guard, and manually rotate the entire barrel assembly 180 degrees. This brought a fresh, primed barrel into alignment with the single flintlock mechanism.

The genius—and the "Achilles' heel"—of the Golcher was the swivel-breech. It required watchmaker-level precision to ensure the flash pan of the second barrel stayed sealed while rotating. If the tolerances weren't perfect, the priming powder would spill out, leading to a literal "flash-in-the-pan" at the worst possible moment.

Carrying two heavy octagonal

steel barrels on a single stock was a physical trial. Most frontier rifles weighed 7–9 lbs; But Golcher rifles tipped the scales at over 10 lbs. It was a specialist's tool, meant for those men who prioritized raw firepower over lightweight mobility.

As one might expect, such specialized and high tech weapons were rather expensive to the point of being unobtainable for the common soldier. Yet during the pinnacle of its popularity, records show that a market had developed for the Golcher among those who could actually afford one.

Novelty and Notoriety

Men like Timothy Murphy and scouts in particular, though rarely if ever men of means, were akin to special operators today, and as such were entitled to bounty money, and battlefield spoils. Making it a profession in which a resourceful man could actually acquire enough money to kit themselves with the finest weapons and tech available. And such was the case with the Golcher rifle. Murphy likely obtained the rifle he famously used to such great effect after Saratoga, when he married Margaret Feeck. She was the daughter of Johannes Feeck, one of the wealthiest patriots in the region. The Feeck family lived in a fortified stone house and owned vast acreage. A custom-ordered Golcher swivel rifle—costing the equivalent of several months'

salary—was almost certainly a "life insurance policy" provided by his new father-in-law to ensure the valley's most effective defender stayed alive during the period brutal Tory raids in the region.

There is more than ample reason to believe that the Golcher rifle had become the weapon of choice for many elite scouts at that time. Gunsmithing records from the Easton district reveal that while standard rifles were mass-produced, "swivel-breech" orders were specifically tied to independent scouts and wealthy frontiersmen. These were men who operated outside the standard "linear" warfare of the Army and unconstrained by army policy, had a free hand to seek out and avail themselves of more specialized and innovative weaponry that would give them a tactical edge.

In journals from the 1780 attack on the Middle Fort, Tory observers frequently mentioned the seemingly "supernatural" rate of fire coming from American scouts. The ability to hold a second shot in reserve that the Golcher provided, preventing the user from being rushed while reloading would wind up giving the gun a sort of mythic status as a "supernatural" weapon. With British soldiers cubbing it a "devil gun" and it Amerindian warriors being so unnerved by it, that they sometimes referred to it as a "spirit gun." With an abundance of accounts attesting to this, it is tempting to won-

der whether the gun was more deadly to the mind or the body.

The Gradual Slide Into Obscurity and Obsolescence

All of this begs the question: If the swivel rifle was so effective and popular among scouts, why did it disappear? Like most early innovations in high tech weaponry from this period, The Golcher rifle had its share of drawbacks:

The "Gunk" Factor: Black powder is a filthy propellant. After just three or four rotations, carbon buildup (fouling) would often jam the swivel mechanism, turning a high-tech marvel into an expensive, two-barreled club.

The Percussion Wall: The final blow was the ignition. A swivel-barrel flintlock required two separate flash pans and frizzens, doubling the risk of damp powder. When the percussion cap arrived in the 1820s, gunsmiths could finally build fixed double-barrels that were slimmer and more reliable. The "mechanical gymnastics" of the Golcher became obsolete overnight.

In spite of this, surviving specimens of Golcher rifles such as those held by the Schoharie County Historical Society and the Smithsonian show heavy "field wear" on the swivel mechanisms. Proving that up until their obsolescence, these weapons saw extensive service.

The Legacy of a Forgotten Firearm

Today, the Golcher Swivel rifle represents the pinnacle of American frontier ingenuity and is often overlooked as one of the many early innovations in guncraft that though forgotten, served not just the men who defied an empire in defense of home and hearth and their liberties, but as stepping stones to the AR-15 and other platforms in common use today. Contrary to the popular talking point of gun control advocates, The Founding Fathers didn't just know of such weapons but sought after them at various times. The Golcher rifle survives today not just in lore and annals, but in museums around the country. ★

My Old Friend, “Rambo”

In December of last year, I finally caught up with my hero, the Green Beret Colonel named James Bo Gritz, the most decorated combat soldier since WWII.

I first met the Colonel (pronounced “kernel”) way back in 1979 as I recall, at a trade show in Las Vegas, where he was the main speaker at a patriot convention. He was so impressive and such a brilliant speaker—he just unintentionally intimidated everyone, especially me! At that time, I was a frequent journalist for *American Free Press*, and it was my intention to interview the famous man (from the Vietnam War) for a front-page story for the paper. However, Colonel Gritz was so overwhelmed with photographers and other members of the press that I missed my chance.

A few years later, I met him again at a convention in Texas, where “Rambo” (made even more famous by Sylvester Stallone’s *Rambo* movie) was speaking and giving a first-hand report on the federal siege and assault on a veteran, Randy Weaver, and his family at their Idaho home in the mountains, during which FBI snipers murdered Randy’s wife and one son, while also wounding Randy and a family friend. All of us were shocked and angered upon hearing these horrendous and “bloody” words from the man who voluntarily interceded between the 400 FBI agents and the small Christian family in the rural mountains of Idaho.

Although Gritz had succeeded at entirely defusing the Ruby Ridge standoff, Randy Weaver, also a Green Beret, was immediately arrested and locked up for three years.

After Randy was released from prison, he retained the famous Wyoming attorney, Gerry Spence; then sued the “Feds” and won and received a multi-million-dollar settlement.

Anyway, in October of 2025, I did obtain Judy Gritz’s cell phone number (Bo’s wife), wherein I introduced myself and my great admiration for her famous

Christian-Mormon husband. Her exact first words to me were: “I have been expecting your call; Carol told me about you.” I was absolutely astounded by her warm reception.

To make a long story short, I informed Judy that this was my third attempt to interview “Bo” and would such a meeting be possible, and if so, where and when? She warmly said “yes” and invited me to their home in Sedona, Arizona. Wow! I happily informed her of where I lived, also in Arizona, and my deceased parents also lived in Sedona. (What a coincidence!)

However, this first meeting with Mrs. Gritz and third meeting with Colonel Gritz was not to be. We set an appointment (for all weekend!) to get together with plenty of time for lunch, dinner, and talk. Bo Gritz could hear our conversation on that phone call, and He approved!

Needless to say, I was ecstatic! “I’ll see you at noon on Saturday, November 20th,” I said, and she responded, “We will look forward to seeing you then.” Wow, again!

Mr. and Mrs. Gritz knew I would be traveling to three appointments I had in Colorado, Wyoming, and Sturgis, South Dakota, during November, and that I would see them on my return from Wyoming. I was excited to take this trip and see so many of my old commercial friends and tell them about my “invitation” to see Rambo and his wife on November 20th.

They were all impressed

with my “date in Sedona”! My traveling van was all tuned up, all new tires, windshield wipers, etc., and “running like a million bucks.” But alas, on my way back to Arizona, my van’s engine blew up on me at 10 A.M. in the middle of the desolate Wyoming prairie!

Once again in my business life, “Murphy’s Law” took over and prevented me from succeeding in one of my most important endeavors. From that morning on, for the next ten days, “hell took over for me,” and I was forced into huge expenses and loss of time.

I phoned Mrs. Gritz from my hotel room (finally in Cheyenne) and explained my predicament and that it was impossible for me to be in Sedona by November 20th. She was very understanding and somewhat sad but informed me that they would be going back to their other house in Las Vegas on November 25th. My response was: “Well, I have a trade show to attend in Las Vegas in early December; can I come and see you both during that time?” Bingo: she said “definitely!” (Wow, again!)

Now mind you, dear reader, Judy Gritz did not disclose to me that her husband was in declining health, but she had told me earlier that “Bo was suffering a little from Alzheimer’s.” Be that as it may, I did visit the Gritzes three times in one week at their home for lunch and chats, but the last meeting with Bo was in the Las Vegas hospital.

Since the meetings at their house,

Bo had had a relapse (and had taken a serious fall) that I did not witness. Judy had phoned me at my hotel in Vegas, informing me that Bo had been in the hospital for three days and “he was recovering!” “That’s good news, can I come and see him tomorrow?” She said yes, and that I could come tomorrow at 11 A.M., and that he is in good spirits.

End of this recent true story is this: what a very great honor it was for me to be accepted as a Vietnam-era old friend by the Colonel and his wife.

Although our time together was rather limited, I was overwhelmed by the graciousness and aura of this “larger than life” man and his incredible wife Judy. It was truly one of the highlights in my life. My two-hour meeting I had with Bo that day in the hospital burns in my mind like a happy, colorful movie. Mostly, he spoke to me directly, while I listened intently to his words, his war stories, and his history. I told Bo a little of my history too; that I am a Mormon also and had been following him and his career for forty years. He seemed impressed.

As the several doctors entered Bo’s room, where Judy and I were sitting, they spoke to Bo in very specific medical terms and informed him of two things: he was being discharged, and they gave him an extensive verbal report on “his bone cancer.” I was shocked to hear such words from those doctors; Bo was not shocked. Whereupon the 4 doctors departed, and I did also.

My final farewell to the Great Man was happy, and very strong handshakes, photos, and good words. Although Bo looked healthy, alert, and happy, all three of us knew his time would soon be up. As I turned to leave, we exchanged these words and a very formal military salute to each other: “God Bless you Colonel, and I’ll see you again, soon I hope.” Bo responded, “You bet!”

Sixty days later, James Bo Gritz departed into his life of eternity, and I did shed many tears. Maybe I’ll see him again in Valhalla. ☆

Confused Republicans Vs. Determined Democrats

The Democrats and their Leftist supporters are operating from an agenda. It is concise, detailed, all encompassing, and completely documented. In 2024, the election of Donald Trump was aimed at returning the Founder's ideas of freedom to American society. But while patriotic Americans took a breath, the Democrats dug in. The World Economic Forum held an Urban Transformation Summit in San Francisco to design a plan to keep the agenda moving forward at the local level. They have been training over 20,000 private NGOs to take their agenda directly to state legislatures and city councils. These are the shock troops to carry forward the agenda. On October 5, 2025, the WEF held another summit in Wichita, Kansas, announcing that Kansas has been chosen as the "Laboratory for Remobilizing Globalization!"

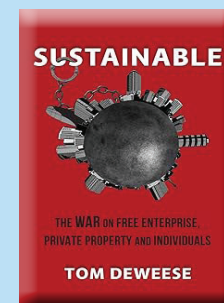

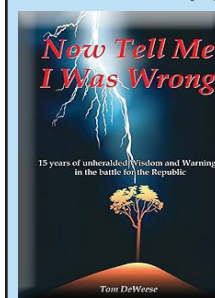

The Second Amendment and the Good Ol' Days"

The Big Beautiful Bill as passed included a provision that repealed requiring law-abiding US citizens to pay a \$200 fee and then wait for perhaps months for permission to buy and install hearing protection devices on their firearms. As hearing protection is an important part of shooting safety, noise suppression devices are hardly novel or new. They are as old as car mufflers and millions of American gun owners already have them installed on their guns.

In a no-nonsense opinion, SCOTUS handed Mexico and US gun control fanatics a stinging rebuke, ruling 9-0 that their lawsuit, *Smith & Wesson Brands v. Estados Unidos Mexicanos*, failed to make a valid legal claim that gun manufacturers aided and abetted illegal arms trafficking in Mexico by manufacturing and selling those weapons to Mexicans. The opinion was written by the usually ultra-liberal Justice Elena Kagan, an Obama appointee and hardly a gun aficionado! Justice Kagan's opinion gave her a chance to show that she had the actual bonafides to make such a bonafide Supreme Court decision. The plaintiffs attempted to "stiff" the Protection of Commerce in Arms Act but instead created a precedent that could shoot down future bogus efforts to circumvent Congress' intent in passing that law. Mexico had faulted the gun manufacturers for producing so-called "military style" assault weapons. but those weapons "are both widely legal and bought by many ordinary customers," the Court determined.

SCOTUS also recently declined to take up a pair of major Second Amendment cases brought up by the States of Maryland and Rhode Island. In the Maryland case, the Court upheld the right to sell and possess several common semi-automatic rifles including the popular AR-15 within that State. In the Rhode Island case, the court declined to hear

challenges to unconstitutional bans on popular firearms and standard capacity magazines in the "blue" states of California, Delaware, Illinois, New Jersey, Oregon and Washington, a decision that was intended to restore Second Amendment rights to law-abiding Americans.

In another crucial decision, Citigroup has issued a press release declaring it is reversing its policy of discriminating against gun manufacturers as well as stores with federal arms licenses and other firearms-related businesses. Not every attack on the Second Amendment arises in the courts!

Yes, guns are common, but not as yet "traditional" in the former sense. However, matters are starting to turn around, perhaps returning to the way things

used to be in the days of our grandfathers. Back then, Sears would have a gun department, catalogs that listed guns and Christmas ads in magazines -- including kids' magazines -- that extolled .22 rifles or .410 shotguns as suitable gifts for boys and girls -- not to mention the always popular bb gun. Sometimes the ads pictured entire families displaying the new guns around the Christmas tree. High schools had rifle teams, even in New York City. Many of the City's public high schools had shooting clubs and a few even had gun ranges on their premises. Elsewhere, high schoolers would hunt on the way to and from school, storing their guns in their school lockers. Pickup trucks in high school parking lots had gun racks, sometimes with rifles or shotguns plainly visible. Summer camps and Boy Scout troops

usually taught the proper use of handguns and rifles. None of this was controversial. The "gun culture" was just another part of the general culture as it had been for two centuries as illustrated by the monuments to America's revolutionary "Minutemen."

Nowadays, despite attacks -- political and cultural -- from the far left, guns remain common while the gun culture booms in response to increased violence in the culture. Increasingly, schools have shooting teams again as do the Scouts; and even lefties are buying guns for self-defense, quietly, of course. But still, guns are treated as political statements by some while others keep them in secret, afraid what friends or neighbors might say.
